In the references 2nd to 7th cited, it has already been requested to all Secretaries/HoDs to ensure the availability of the following IT infrastructure with the minimum Specifications mentioned below.

a	Computer System	2 Nos 2.0GHz Processor, 4 GB DDR3 RAM, Sufficient Storage (300 + GB Hard Disk), 4 USB 2.0 ports, Pre-Located Microsoft OS (windows 10/09/08).
b	Scanner	1 No.
c	Printer	1 No
d	Connectivity	Any Public connectivity with static IP. (if TNSWAN connectivity is not available, then public connectivity was suggested with static IP). Provision of redundant connectivity was also suggested as alternate connectivity to avoid disruptions.

It has been planned to implement the IFHRMS software in a full-fledged manner w.e.f 01.04.2019. Thereafter, all Pay and Accounts Offices / Treasury Offices will be able to accept the bills prepared and presented through the IFHRMS application only.

Hence, I once again request to ensure the availability of the above said infrastructure at all DDOs locations in your department for preparing the bills in the IFHRMS application, I seek your kind support and coordination for efficient transition to the new system.
