
Kind attention is invited to the Government letters cited wherein detailed guidelines had been issued for the allotment of RBE 2021-22 to the sub-ordinates offices on or before 28.09.2021. The monitoring of the budget allotment by the below level offices has been facilitated in the system, through an updated 'Budget Allocation' status report and periodical emails have also been sent to expedite the process. Despite all the measures and the bounden responsibility of the departments concerned, as per the Budget Manual, the budget allotment till the last level DDOs has not been completed in respect of the BCOs mentioned in the Annexure.

2. In view of the above, it has been decided to close the budget allocation activity in the system on 22.12.2021 and the HoDs should ensure that their defaulting offices complete the allotment before the closure date and if any public inconvenience is caused due to the non-completion of the mandatory budget allotment function, the concerned BCOs, will be held responsible for the lapses.

3. Further, in respect of allotment of Capital and Loan Expenditure it is construed that, the current allotment level as depicted in the budget allocation status report is final for all the HoDs and for the same reasons stated for the Revenue Expenditure allotment, the Budget allocation activity will be closed in the system for the Capital and Loan expenditure activities also on 22.12.2021.
