Message:	In G.O.Ms.No.113, Finance (T&A-III) Department, Dated 14.05.2025, the Government have accorded permission for execution of MOU with the following banks to provide the Term Life and Personal Accident coverage insurance benefits to the Government employees maintaining their salary accounts in the concerned banks. <ol style="list-style-type: none">1. State Bank of India2. Indian Bank3. Indian overseas Bank4. Axis Bank5. Bank of Baroda6. Union Bank of India7. Canara Bank.

		<p><u>Updates:</u></p>	<p>The above banks maintaining the employee salary account are providing minimum of Rs.10 lakhs Term Life Insurance Coverage and Rs.100 lakhs Personal Accident Insurance Coverage to the Government employees. In the event of an employee's death, due to accident, their children will receive the educational benefits and unmarried daughters will get marriage assistance at no cost.</p> <p>All the Drawing and Disbursing officers are may be requested to instruct their employees to ensure that their salary account with the above empaneled banks are tagged under "State Government Salary Package" scheme to avail the insurance benefits like Term Insurance and Personal Accident Insurance, etc.,</p> <p>A pop up message has also been shown in the Kalanjiyam Portal page to know about the bank wise offers in detail and to download the same in the excel format .</p> <p>All PAOs/TOs are requested to disseminate the information regarding the process of claims and benefits of the scheme to the DDOs.</p>

2. Re-orientation Points:

1.	Income Tax- updation of TDS paid through Bank IT Challan (Not through IFHRMS echallan)	<p>Issue:</p>	Repeated tickets are being received from the users that the Income Tax paid through Income Tax challan (should not be remitted through IFHRMS e-challan) is not getting updated in the system which results deduction of higher amount of Income tax from the salary of the employees.
		<p>What to do:</p>	Provision available in the portal to update the TDS paid through Income Tax Challan(through Bank) under the "Other Income-TDS Paid" column.

		Path:	Portal-> login->Employee Self Service->Income tax declaration->declare savings and other income details and TDS paid on other income.
2.	Bill Page Attachments-enabled preview option to view the documents.	Issue:	Repeated requests are being received from the DDOs to give option to view the bills page attachments before downloading the documents. This option will help the DDOs to preview the documents by avoiding the downloading of unwanted documents.
		What to do:	Now provision has been enabled to preview the documents in the bills page attachments without downloading the documents (Both view/download option is available). This facility is available to the Initiator, verifier and approver and the initiator alone will upload the documents.

All Pay and Accounts Officers and Treasury Officers are requested to

1. Maintain separate file for all the advisories being shared and sensitize all officials of treasury offices by all modes of communication (U.O.Note, letters, e-Mail etc.)
2. Similarly, the same has to be shared with **all Drawing and Disbursing Officers and aided institutions** by possible modes of communication (letters, e-Mail etc.)
3. **Monthly meetings / re-orientation sessions** have to be organized for all subordinate offices, DDOs and aided institutions to ensure proper dissemination of all updates.
- 4 . **All Regional Joint Directors** are requested to ensure proper communication to all stakeholders and conduct of monthly meetings at all Treasury offices.
