Directions.- 1. Pension bills should the presented on one of the days indicated below to the Pension Pay Office. Bills will not be received after 12.30 p.m. Cheques will be issued on the Reserve Bank of India. Madras for sum above Rs. 500 smaller amount will be paid in cash. When the sum exceeds Rs. 20, the bill should be stamped—

On the first day of the month provided it is not a holiday.

On the second working day of the month

On the third working day of the month

On every Tuesday Except last Tuesday of the month.

2. If a pensioner fails to appear by the third day allotted, he will be paid on the following Tuesday or any subsequent Tuesday in the month (and if the Tuesday is a holiday) on the following working day. The only exceptions to this rule are the claims of pensioner paid for the first time and these on account or deceased pensioners.

3. As a rule, a pensioner must take payment in person, unless he produces a life certificate signed by one or other of the person named below, showing that the pensioner was alive on the last day of period of claim.

- (a) Pensions exercising the powers of Magistrate under the Criminal Procedure Code or any registrar or Sub Registrar under the Registration Act or any pensioned officer who before retirement exercised the powers of a magistrate or a Munsif or any Gazette Officer of Government or sub-Inspector of Police in charge or a Police station (Article 946 C.S.R.)
- (b) Any responsible officer of Government or other Well-known and transport person in the case of pensioners exempted form person appearance by Government or a female pensioner not accustomed to appear in public or male pensioner who is unable to appear in consequence of bodily illness or infirmity (Article 946 C S R)
- (c) In respect of pensioners not residing in India, the bank shall produce a life certificate signed by a Magistrate, a Notary, a Banker or diplomatic representative of India.

4. Persons usually obtaining their pension on production of life certificate should appear personally at least once a year for muster Payment on a life certificate will not therefore be made for more than 12 consecutive months. If such a pensioner is physically unable to appear in the thirteenth month of Muster he should submit a medical certificate testifying to such incapacity in addition to producing a life certificate Pensioners specially exempted by Government from personal appearance and female pensioners unaccustomed to appear in public are however not required to appear for the annual muster but the after should furnish annually proof of their continued existences independent of the furnished by the life certificate (Article 947, C.S.R)

5. If a Pensioner who is required to sign a certificate of non-employment is re-employed either permanently or temporarily in Government establishment or in an establishment paid form a Local fund during the period for which the pension is clamed be should furnish the necessary particulars in the certificate indicating the post and the department in which the pensioner is re-employment have been duly observed employment post and the disbursing officer should ascertain whether the rules regarding such re-employment have been duly observed.

6. If a pensioner drawn in arrears for more than one month at a time of a certificate of non-drawal or arrears should be furnished overleaf
